H&I Subcommittee Annual Budget

Submitted to MASC for approval 6/27/21

Beginning 7/1/21 the MASC H&I Subcommittee requests an annual budget of \$720.00.

We are requesting that this be paid out at a rate of \$60.00 per month in the form of a credit for literature. Literature could be obtained with voucher for stocked MASC literature, or the subcommittee could order its own literature and be reimbursed by MASC. Keep in mind that H&I facilities have special requirements for literature that the MASC literature committee may not stock.

\$60.00 represents \$1.00 per month for every unique client we serve each month, which currently is 60.

The total monthly budget is the total amount needed for the facilities it serves. The H&I Subcommittee will not request more than the budgeted monthly amount, but it may request less. Should the number of monthly clients served increase substantially for a consistent period of time, a new budget request will be submitted.
