Service work has many rewards and may have a profound, positive effect on your life and personal recovery. However, it does not come without hard work, long hours, dedication and personal sacrifice. If, after careful consideration, you feel the need to decline your nomination at this time, your peers will certainly understand and respect your decision to wait until you can freely make the necessary long-term commitment.
