Page 8, section X.G

Current verbiage: "Motions that affect existing policy must be referred to member groups to be decided at the following MASC meeting."

Proposed change: "Motions that affect the content or intent of existing policy must be referred to member groups to be decided at the following MASC meeting. Housekeeping changes, which involve only corrections to spelling, grammar, or format of policy, may be voted on by the Policies and Procedures Subcommittee, if operable. If housekeeping changes are needed, the Policies and Procedures Subcommittee Chairperson must provide a written record of what changes were made in the relevant report at the next MASC meeting."

Intent: to speed up MASC, subcommittee, and home group business by reducing the number of motions which go back to groups on which groups would likely have no strong opinions (i.e. the correction of a spelling error), while also keeping the Policies and Procedures subcommittee publicly accountable for changes made to policy.

Page 5-6, section VI

Current verbiage: N/A

Proposed change: to add a section VI.H which would read:

"Ad hoc Subcommittees may be established on a temporary basis in order to perform a function which cannot be performed by MASC as a whole or a standing subcommittee. The Ad hoc Subcommittee Chairperson will be appointed by the Area Chair, and the duration of existence and function of the subcommittee should be set at the time of appointment. The Ad hoc Subcommittee will provide a report monthly and be accountable to MASC in the same manner as standing subcommittees. The Ad hoc Subcommittee will be dissolved immediately upon fulfillment of the purpose, or the end of the term, whichever occurs first."

Intent: to outline a procedure for the establishment of ad hoc subcommittees where there was none. This policy is modeled after the Volunteer Region's policy (page 23, article XIII, section 7), and was temporarily adopted by group conscience in June 2023 for the establishment of an ad hoc committee to investigate the feasibility of a MANA convention.
