I've attended numerous personal development programs throughout my career, created and built multiple team building programs and have an extensive resume in communications and organizational development. I attended to undergrad and graduate school. Currently building a board for a not-for-profit serving recovery community in our County for sober living support, case management, MH, medical referrals, employment and transportation. I'm actively involved in my home group and have been providing direct aid to homeless addicts in our community. I help addicts seeking help get placed in an extremely difficult environment riddled with lack of resources and beds. My career is recovery focused now providing support and aid to individuals struggling with addiction, homelessness and MH. Please include any other information you consider relevant to your nomination: I'm extremely active in my home group and take my service commitments very seriously. I am super clear that I keep my own gift of recovery by giving it away to others. The value of one addict helping another is a natural expression of who I am and deeply ingrained in my personal and professional life. I have never misappropriated NA funds and have had ample opportunity to do so. I work the 12 steps and have a sponsor who has a sponsor who has a sponsor. 




