I was able to virtually attend the most recent Volunteer Region Service Committee. Also attending from the Mountain Area was Greg V. as the delegate to the zone. Rick M. our RCM-Alt was not present.

News from around the Volunteer Region

- VRC 43, will be held in Memphis over the Thanksgiving weekend. If you have group members seeking to speak at or chair workshops during the convention, I need names and contact info by the end of this month, so I can submit to the VRC program director.
- Discussions continued around changes for future conventions. Pros and cons for topics such as: changing the dates; movement to middle of the state; term extensions for admin positions; creation of an oversight committee; changing frequency to every two years; stricter budget guidelines; and increasing registration pricing. These topics and others will continue to be discussed. Policy changes will not take place until next year and implementation of any changes will not take place until VRC 45 (2027).
