I did attend the CAR Workshop that was in Knoxville on January 17th. The Meeting was facilitated by our Regional Delegate. There was lively discussion on all 5 of the motions that are in the Conference Agenda Report. Attendance was about 15 members for the 2 1/2 hour workshop. I'm sure our Regional Delegate will report more on the specifics.

I attended the SHITLOTS Convention in Ashville, NC. It was surprising to me how large the paid registration count was, more than 970! They also tallied the clean time totals for the registered attendance which were just under 10,000 years of clean time!

The success of this near by convention gives me confidence in the likely success of our upcoming 2026 Unity in the Mountains Convention.

I also had a conversation with James B., of Knoxville in followup with a conversation he had a couple months ago with Barry, our Activities chair. James is the Knoxville Activities Chair. 
