Regional Committee Member Report

February 15th, 2026

Good morning Mountain Area Service Committee,

I attended the scheduled VRC meeting via ZOOM on February 1st 2026.
Of the 11 active areas, there were 9 areas represented. Quorum was met.

The vacancies in the Regional Admin body are currently; Policy & Procedure, Hospitals & Institutions, The Alternate Regional Delegate, and at this meeting the Regional Vice-Chair expressed that she will withdraw from her service commitment due to health reasons at the end of her term. Elections will be held in November for the VRSC Admin body.

There was a New area that requested to join the Volunteer Region and it was accepted. The newest area is the "Tennessee Valley Area". This Area formed with a desire to better serve addicts in this very rural area.

Also of note, the North Alabama Region of NA, has expressed their intention of joining the Volunteer Region in January of 2027.

During this meeting I brought up the concerns of this body with regards to the timely deposit of funds that are donated to VRSC. The response I received was that, "I forgot to check the P.O.Box". I explained our ASC's concerns about timely handling of NA funds and areas decision to withhold our most recent donation pending resolution of these concerns. The Chair person directly requested that the Treasurer commit to making a better effort at managing the P.O. Box and making timely deposits. He agreed he would do that.

I asked about options to make direct electronic transfers to VRSC and was told that the Corporate account at Regions was not able to receive electronic deposits. I personally went into a Regions Bank office and inquired about this concern. After a detailed explanation of my question and concerns, I was told that that it is possible. I will continue to pursue this is to try and find a solution for our donations to VRSC.

The Issue of Liability Insurance was also discussed. This issue is not one that appears to be moving forward much at all at this time. I was told that if our needs were urgent, MANA Service committee was free to move forward on their own. I made several efforts to reach out to Insurance brokers, including phone calls and emails. I did not hear back from anyone. It is my intention this next week to start going directly to the office and make contact.

There was one motion returned to the Areas to be offered to the groups.

At our next meeting, I have requested that written budgets be submitted for the anticipated expenses and costs moving forward and will report on those outcomes this next month.




