Regional Committee Member Report

June 14, 2026

Good afternoon to all,

There has not been a Volunteer Regional Service Committee since my last report. There will be a Mid-Casual, ZOOM only, Meeting of the Committee on this coming Wednesday, June 17th at 7pm eastern time. I will be attending that meeting and will report next month. The next in person meeting will be August 2nd, 2026.

I wish to give this Service Committee notice of my absence for this ASC meeting in the month of August. I will be traveling for several weeks. I will submit an electronic report as needed.

Today I would like to collect the Survey Questions that I gave each group last month. Thank you for taking time to address this task in your Home Groups.

The issue of obtaining an Area Liability Policy is progressing slowly. I have received a quote for two different types of policies. One is a Liability policy only and the other is a Liability & Property Damage policy combined. After combing through this insurance quote, I have doubts that this is the right policy for our particular needs. I have spoken with a couple of other knowledgeable members and they agree with my concerns. Moving forward, I was given a Certificate of Insurance, a Common Policy Declaration, and a General Liability Coverage Supplemental Schedule from another Region. This, I believe, will be good in helping to focus in on our exact needs using these examples.

I realize that this process is dragging on and some groups have urgent needs for proof of coverage. Unfortunately, this is not going to happen quickly. Relocating to another meeting place may be needed if your group is being challenged to provide a Certificate of Liability Insurance. In a Best Case situation, a policy is presented to this ASC next month, it is sent to the groups to vote on, approved, signed, and paid in full, the effective date is at least 3 months from now, and likely longer. Paying several thousand dollars for a policy that when needed is denied coverage would be a huge waste of money for this ASC. It is imperative to get this right. Please, be patient as this complex issue is worked through. I am happy to answer any questions you may have.

Please remind your groups that the Alternate RCM position is open at this ASC. Also, there are openings a the Region for, Policy & Procedures, and H&I.
